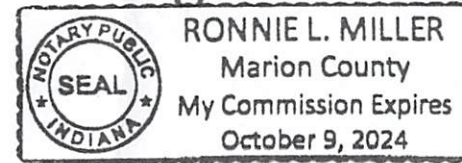


U.S. Term Limits Pledge
